Rules and Policies:

You will be working with animals in the adoption program, but must keep in mind the following policies:

- DO NOT enter restricted areas of the building. Bite cases and contagious animals are being kept quarantined for a reason. These animals may be dangerous. Only animal control employees are allowed in these quarantined areas.
- Do not put any toys, treats, or food in kennels without permission.
- Do not move any animal from one kennel to another or allow an animal to go into another animal's kennel.
- Do not open stray cat kennels. These cats may be dangerous or they may escape.
- Do not attempt to touch any animals labeled "Do Not Touch" unless instructed otherwise.
