APPEALS TO THE BOARD OF ADJUSTMENT CONCERNING INTERPRETATION OR ADMINISTRATION OF CHAPTER 104 MAY BE TAKEN BY ANY PERSON AGGRIEVED OR BY ANY OFFICER OR BUREAU OF THE PARISH COUNCIL AFFECTED BY ANY DECISION OF THE ZONING ADMINISTRATOR. SUCH APPEALS SHALL BE TAKEN WITHIN A REASONABLE TIME, NOT TO EXCEED 45 DAYS OR SUCH LESSER PERIOD AS MAY BE PROVIDED BY THE RULES OF THE BOARD, BY FILING WITH THE ZONING ADMINISTRATOR AND WITH THE BOARD OF ADJUSTMENT A NOTICE OF APPEAL SPECIFYING THE GROUNDS THEREOF.
